# **COMPOSITION OF ICC**

## **ICC Comprises:**

- Presiding officer (Female Staff)
- Two faculty Members
- One Non-Teaching staff
- Student representative (Rotational)
- One external Member

#### **Power & Functions of ICC:**

- To receive complaints of sexual harassment.
- To conduct inquiries in a time-bound manner.
- Recommend disciplinary actions to the Principal
- Organize awareness programs and sensitization workshops.
- Ensure confidentiality and non-retaliation.

## Guidelines & Structures for All Staff and Students

#### A. General Guideline:-

- Zero tolerance for sexual harassment and eveteasing.
- Display of posters in college premises highlighting consequences.
- ICC contact details to be displayed prominently.
- Sensitization sessions must be held twice a year.

#### B. Reporting & Redressal:-

- Complaints must be submitted in writing to the ICC within 3 months of the incident.
- ICC to complete inquiry within 90 days and recommend action.
- Retaliation against complainants/witnesses is strictly prohibited.

# Do's and Don'ts for Faculty, Staff & Students ▼ DO's

- Maintain respectful professional relationships.
- Support awareness campaigns and attend gender-sensitization programs.
- Report incidents either experienced or witnessed.
- Encourage students to speak up without fear.

#### **XDON'Ts**

- Do not indulge in inappropriate jokes, comments, or gestures.
- Avoid unwelcome advances r physical proximity.
- Do not misuse your position to intimidate or harass.
- Do not tolerate or ignore complaints—act responsibly.

## **Penalties for Misconduct:**

- Written warning
- Suspension from duty/classes
- Debarring from exams/roles
- Termination or expulsion based on severity
- Legal action as per IPC/UGC norms

### Awareness & Training Initiatives

- Mandatory induction session on gender sensitization for fresher's and new staff.
- Quarterly workshops by ICC and external experts.
- Feedback forms to assess campus safe
